**Explanatory Notes (As per FRS 134)**

**A1 Basis of Preparation**

The interim financial statements are unaudited and have been prepared in accordance with FRS 134, Interim Financial Reporting and Paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad.

The interim financial statements should be read in conjunction with the audited financial statements of the Group for the year ended 31 December 2007. The explanatory notes attached to the interim financial statements provide an explanation of events and transactions that are significant to an understanding of changes in the financial position and performance of the Group since the year ended 31 December 2007.

**Changes in Accounting Policies**

The significant accounting policies adopted are consistent with those of the audited financial statements for the year ended 31 December 2007 except for the adoption of the following new/revised Financial Reporting Standards ("FRS") issued by The Malaysian Accounting Standard Board ("MASB") effective for the financial period beginning 1 January 2008:

The adoption of the above mentioned FRSs is not expected to have any significant impact on the Group. The Group has not adopted FRS 139 Financial Instruments: Recognition and Measurement as its effective date has been deferred.

**A2 Audit Report of Preceding Annual Financial Statements**

The audit report of the Group's annual financial statements for the year ended 31 December 2007 was qualified as follows:

- (a) Unaudited financial statements of a subsidiary, Times Engineering System Co. Ltd. have been used for the preparation of the consolidated financial statements of the Group due to the unavailability of its audited financial statements. The net profit for the year, total assets and total liabilities as of 31 December 2007 of this subsidiary company that have been consolidated based on its unaudited financial statements amounted to RM4,471,180, RM1,633,773 and RM5,702,960 respectively. The external auditor is unable to ascertain the possible adjustments to the consolidated financial statements that might have been necessary had the audited financial statements of this subsidiary been made available.
- (b) All the accounting records of a subsidiary company, LETC Engineering Sdn. Bhd ("LETC") for the financial year ended 31 December 2006 were destroyed in a fire. Owing to the nature of LETC's records, the external auditor is unable to obtain adequate documentary evidence to satisfy themselves as to the fairness of the opening balance of property, plant and equipment of RM167,018, trade and other payables of RM4,419,029 and accumulated losses of RM5,033,924 as at 1 January 2007 by means of other auditing procedures.

### A3 Seasonal or Cyclical Factors

The operations of the Group were not materially affected by any factor of a seasonal or cyclical nature for the current financial period.

### A4 Exceptional Items

There were no unusual items affecting the assets, liabilities, equity, net income or cash flows of the Group for the current financial period.

### A5 Changes in Estimates

There were no material changes in estimates that have a material effect in the current financial period.

### A6 Issuance and Repayment of Debt and Equity Securities

Saved as disclosed below, there were no issuance and repayment of debt and equity securities, share buy-back, share cancellations, shares held as treasury shares and resale of treasury shares for the financial period ended 31 March 2008.

- a) As at 31 March 2007, the issued and paid-up share capital of the Company stood at RM75,104,777 inclusive of 2,949,700 shares held as treasury shares.
- b) Total number of outstanding share options granted under Linear Employees' Share Option Scheme and not exercised as at 31 March 2008 amounts to 1,590,000.

No dividend was paid by the Company during the current financial period.

**Explanatory Notes (As per Bursa Malaysia Securities Berhad Listing Requirements)**

**B1 Review of Performance**

For the period ended 31 March 2008, the Group registered a revenue of RM24.2 million as compared to RM7.3 million for the preceding year's corresponding period. The Group reported a gain after tax of RM3.6 million for the current quarter under review as compared to a loss after tax of RM1.7 million in the preceding year's corresponding quarter.

The increase in revenue was mainly due to the additional sales generated from the solar panel sales and the increase in profit was due to the gain arising from the disposal of its subsidiaries.

**B2 Comparison with Preceding Quarter's Results**

The Group recorded lower revenue of RM24.2 million as compared to the immediate preceding quarter of RM102.9 million. Arising from the decrease in revenue in particular the solar panel sales, the Group reported a profit after tax of some RM3.6 million in the current quarter against a profit after tax of RM5.9 million in the immediate preceding quarter.

**B3 Current Year Prospect**

The Group after considering the current conditions is expected to achieve better performance for financial year ending 2008.

There was no profit forecast or profit guarantee issued by the Group.
